

# **PRIVACY POLICY**

This privacy policy sets out how Toucan Internet LLP uses and protects any information that you give to Toucan Internet LLP when you use this website and other group websites. Toucan Internet LLP is, and always has been, committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website and other group websites then you can be assured that it will only be used in accordance with this privacy statement. For the purposes of the General Data Protection Regulation 2016 and the Data Protection Act 2018 and the regulations made under them (the DP Law), the data controller and data processor is Toucan Internet LLP in relation to personal data as defined in the GDPR ("Personal Data").

## Information we collect from you.

We will collect and process the following data about you:

#### Information you give us.

This is information about you that you give us by filling in forms on our site http://www.toucanweb.co.uk and other group websites or by corresponding with us by phone, email, in person or other methods. It includes information you provide when enquiring about our services, and/or engaging us to provide services. The information you give us may include your name, company, address, email address and phone number or other specific information which is relevant to our services and our business relationship.

#### Information we collect about you.

Our policy is to collect no personal information about you when you visit the toucanweb.co.uk or other group websites, unless you affirmatively choose to make such information available to us. When you visit the toucanweb.co.uk website or other group websites, the web server automatically recognises and logs the Internet domain, the IP address from where you accessed the site, browser details, time details, files accessed, server response codes, operating system and platform. This information does not result in the identification of your personal email address or other personal information. This is done so that the content of the site can be improved, and your personal information is not identified.



If you choose to share personal information, by such means as filling out a web form or emailing us with personal information, the information will not be disclosed to third parties, unless required by law or with your express permission.

#### What we do with the information we gather.

We require this information to understand your requirements and provide you with a better service, and possibly for the following reasons:

- To improve our services
- To individuals who opt in to marketing communications to advise of other services that should be of value or similar communications
- To carry out our obligations arising from any subsequent contract between Toucan Internet LLP and you

#### How long we will hold the information.

We will hold the information for any processing required for any contract we have with you and for a reasonable period thereafter. We review personal information held on a periodic basis and delete information which we assess will no longer be required for any future dealings between you and us.

## Security.

We are committed to ensuring that your information is secure. To prevent unauthorised access or disclosure we have suitable procedures to safeguard and secure the information we collect online in place.

## Cookie Policy.

This website and other Toucan Internet LLP group websites use cookies. These are small text files that are placed on your computer to help the site provide a better user experience. Cookies are used to retain user preferences, store information essential to function such as shopping carts, and provide anonymous data to third party applications like Google Analytics.

Cookies are used to make your browsing experience better. You have the option to disable cookies on this site and on all sites you visit by changing your browser settings. The most effective way to do this is to disable cookies in your browser and the help section of your particular browser will advise how this is done or take a look at guidance from the Information Commissioner's Office.

It is considered that any data collected from you via web forms completed on this website or other group websites is deemed "opt-in" with your permission to be stored in our marketing database.
